## ARTICLE 1 - SUBJECT MATTER OF THE AGREEMENT

---

- 1.1 The institution shall provide support to the participant for undertaking a mobility activity for student mobility under the Erasmus+ Programme.
- 1.2 The participant accepts the financial support or the provision of services as specified in article 3 and undertakes to carry out the mobility activity according with the Learning Agreement.
- 1.3. Amendments to the agreement shall be requested and agreed by both parties through a formal notification by letter or by electronic message.

## ARTICLE 2 - ENTRY INTO FORCE AND DURATION OF MOBILITY

---

- 2.1 The agreement shall enter into force on the date when the last of the two parties signs.
- 2.2 The mobility period at Babeş-Bolyai University is:

From: date of arrival/date of the beginning of the semester	Until: date of departure/date of the end of the semester

- 2.3 The participant shall receive financial support from Erasmus+ EU funds for the period mentioned in this contract at article 2.2.
- 2.4 The total duration of the mobility period shall not be less than 90 days and cannot be more than the period approved initially by the home and host universities.
- 2.5 The participant may submit any request concerning the extension of the mobility period within the limit set out in article 2.4. If the institution agrees to extend the duration of the originally planned mobility period, the agreement shall be amended accordingly.
- 2.6 The Certificate of Attendance shall provide precise information with regard to the student's arrival and departure dates of their mobility.

## ARTICLE 3 - FINANCIAL SUPPORT

---

- 3.1 The total grant allocated for the beneficiary is ..... EUR, amount consisting of subsistence costs calculated for ..... days of mobility and ..... EUR travel costs.

The subsistence will be calculated as it follows:  $\frac{\text{Number of mobility days}}{30 \text{ days}} \times 750 \text{ EURO monthly grant}$

- 3.1.1 The aforementioned amount will be paid by bank transfer in RON, on a monthly basis, after the signing of this contract.

- 3.1.2 The last month's grant will be adapted to the precise date of departure.
- 3.1.3  The travel expenses with the value of - RON ~ - EUR calculated at infoeuro was paid by BBU based on the invoice emitted by the travel agency at the acquisition of the ticket. The amount of EUR will be subtracted from the first grant payment
- The student personally paid for his travel ticket and receives the budget limit for the declared route.
- 3.2 The reimbursement of costs incurred in connection with special needs, when applicable, shall be based on the supporting documents provided by the participant.
- 3.3 The financial support may not be used to cover costs already funded by EU funds.
- 3.4 Notwithstanding Article 3.3, the financial support is compatible with any other source of funding.
- 3.5 The financial support or part of it shall be recovered if the participant does not carry out the mobility activity in compliance with the terms of the agreement. However, reimbursement shall not be requested when the participant has been prevented from completing his/her mobility activities as described in Annex I due to force majeure. Such cases shall be reported by the institution and accepted by the National Agency.

#### **ARTICLE 4 - PAYMENT ARRANGEMENTS**

---

- 4.1 In maximum 15 working days after the arrival of the beneficiary at Babeş-Bolyai University the money transfer shall be made to the participant representing the financial support from Erasmus+ EU funds as specified in Article 3.
- 4.2 The payments are dependent on the proof of the student's presence in the home country. Each month the student will confirm this personally at the Erasmus+ Office.
- 4.3 The student is not allowed to leave Romania for more than 8 days during the entire mobility period.

#### **ARTICLE 5 - EU SURVEY**

---

- 5.1. The participant shall complete and submit the online EU Survey after the mobility abroad within 30 calendar days upon receipt of the invitation to complete it.
- 5.2 Participants who fail to complete and submit the online EU Survey may be required to partially or fully reimburse the financial support received.

**ARTICLE 6 - INSURANCE**

---

- 6.1 The participant shall have adequate insurance coverage.
- 6.2 Acknowledgement that health insurance coverage has been organised shall be included in this agreement.

**ARTICLE 7 - LAW APPLICABLE AND COMPETENT COURT**

---

- 7.1 The Agreement is governed by Romanian National Law.
- 7.2 The competent court determined in accordance with the applicable national law shall have sole jurisdiction to hear any dispute between the institution and the participant concerning the interpretation, application or validity of this Agreement, if such dispute cannot be settled amicably.
